



Prince Aircraft Company 60-Day Warranty For LA Series Propellers

Prince Aircraft Company warrants its new products to be free from defects resulting from faulty manufacture, faulty components and achieving proper max propeller rpm's under the following terms and conditions:

- I. **Warranty Length.** Prince Aircraft Company offers a 60-Day propeller warranty. Replacement propellers will be warranted from the remainder of the original warranty period or thirty days, whichever is longer.
- II. **Who Is Protected.** This warranty is enforceable only by the original purchaser. Proof of purchase is required for warranty service.
- III. **What Is And Is Not Covered.** Note that our warranty is not an unconditional guarantee for the 60-day length of the warranty. Prince Aircraft Company products are made under our exacting manufacturing standards. But, like any other product, they are not indestructible. Therefore, our warranty does not cover product damage that may result from abuse, mishandling, operation exceeding design parameters, or improper installation, nor does it cover incidental or consequential damage. The following are not covered by the warranty: **1)** Any product which has been modified without permission from Prince Aircraft Company, or on which the serial number or warranty sticker has been defaced, modified, or removed. **2)** Normal wear and tear. **3)** Damage, deterioration or malfunction resulting from: Accident, abuse, misuse, neglect, fire, water, lightning, or other acts of nature, unauthorized product modification; repair or attempted repair by anyone not authorized by Prince Aircraft Company; shipping or transport damage (claims must be made with the carrier); any other cause which does not relate to a product defect. **4)** Cartons, cases, cabinets, tapes, accessories or other consumables used with this product. **5)** Prince Aircraft Company does not warrant that this product will meet your requirements. It is your responsibility to determine the suitability of this product for your purpose. **6)** Removal or installation charges. **7)** Shipping Charges. **8)** Any incidental charges.
- IV. **Exclusion of Damages.** Prince Aircraft Company's sole obligation and liability under this warranty is limited to the repair or replacement of a defective product at our option. Prince Aircraft Company shall not, in any event, be liable for incidental or consequential damage, including but not limited to damages resulting from interruption of service and loss of business, or for liability in tort relating to this product or resulting from its use or possession.
- V. **Limitations Of Implied Warranties.** There are no other warranties, expressed or implied, including but not limited to those of merchantability or fitness for a particular purpose. The duration of implied warranties is limited to the warranty length specified in Paragraph I.
- VI. **Local Law And Your Warranty.** This warranty gives you specific legal rights. You may also have other rights granted under local law. These rights may vary.

If your product needs to be returned within the warranty period, please do so through the retailer or distributor from whom you purchased the product. If the product is still within warranty and you can no longer return it to your dealer, please contact Prince Aircraft Company (see above) for assistance and instructions. **Prince Aircraft Company will not accept returns without prior approval and an RMA number.** When returning product, please be sure to enclose a clear description of the problem and your proof of purchase with the defective product and return it as instructed by Prince Aircraft Company. Be sure to package the product securely (preferably in its original packaging) and ship it postpaid. Your dealer or Prince Aircraft Company will not be responsible for damage due to shipping. During the warranty period, your product will be repaired, modified or replaced without charge, excluding shipping and handling.
